Important Instructions

- I. The evaluation of the product shall be taken up by the laboratory as per the terms and criteria laid down by IoTSCS and Work Order issued by the laboratory.
- II. The final certification report on completion of successful evaluation shall include reference of the application.
- III. The laboratory shall prepare a Test Plan with all stakeholders (CB, Client and the appointed Assessors from IoTSCS)
- IV. The applicant is requested to ensure full cooperation with the laboratory during testing activities as per the terms and conditions of the scheme, by providing the required documents and product under evaluation, responding promptly to observations raised, taking necessary actions as identified, participating in discussions related to the evaluation, adhering to the agreed test plan, and finalizing the commercial terms mutually agreed upon with the laboratory for the evaluation activity.
- V. The Certification body has appointed Validator for this evaluation. They will be continuously associated with this evaluation on behalf of Certification body to oversee the evaluation including witness testing, review of observation report and preparation of Test Report etc. **Validator may be contacted from the inception of the evaluation (Kick-off meeting).**
