- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. - 6. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. 1. Generic

Malicious Code Certificate:

The seller should upload following certificate in the bid:-

- (a) This is to certify that the Hardware and the Software being offered, as part of the contract, does not contain Embedded Malicious code that would activate procedures to :-
 - (i) Inhibit the desires and designed function of the equipment.
 - (ii) Cause physical damage to the user or equipment during the exploitation.
 - (iii) Tap information resident or transient in the equipment/network.
- (b) The firm will be considered to be in breach of the procurement contract, in case physical damage, loss of information or infringements related to copyright and Intellectual Property Right (IPRs) are caused due to activation of any such malicious code in embedded software.

2. Generic

Installation, Commissioning, Testing, Configuration, Training (if any - which ever is applicable as per scope of supply) is to be carried out by OEM / OEM Certified resource or OEM authorised Reseller.

3. Generic

Notwithstanding anything contained in GeM GTC and GeM ATC a nd GeM Special T&C, the intending Bidder(s) must qualify the followin g prescribed conditions in regard to the country-specific terms including those related to control of the bidding entity as mentioned hereun der and also those related to Compulsory Local Content in offered product/services as mentioned hereunder of this Document.

These provisions shall override anything contrary, if otherwise contained in this document. Bidders may please note that this Tender shall be further subject to changes or cancellation as may be due to the change in Policy or Rules or Orders of the Government of India, as may be issued from time to time.

1. Requirements for registration with Competent Authority in respect of bid ders from countries having land border with India

Requirement of registration as per Restrictions under Rule 144 (xi) of the General Financial Rules (GFRs), 2017, read with GOI, MF, DoE, PPD OM no. 6/18/2019-PPD dated 23/07/2020 must be fulfilled by a n interested bidder.

Any bidder from a country which shares a land border with India will be eligible to bid in any proc

urement whether of goods, services (including consultancy services and non-consultancy services) or works (including turnkey projects) only if the bidder is registered with the Competent Authority, specified in A nnex I of the said OM dated 23/07/2020. Registration from this competent authority as may be declared by the Department for Promotion of Industry and Internal Trade (DPIIT), following due Political and Security Clearance from the respective Ministries of the Govt. of India shall be mandatory for such intending Suppliers/Bidders to submit a bid.

Provided that, "Bidder from a country which shares a land border with India" for the purpose of this Order means: -

- a. An entity incorporated, established or registered in such a country; or
- b. **An entity substantially controlled through entities** incorporated, established or registere d in such a country; or
- c. An entity whose beneficial owner is situated in such a country; or
- d. An Indian (or other) agent of such an entity; or
- e. A natural person who is a citizen of such a country; or
- f. **A consortium or joint venture** where any member of the consortium or joint venture falls un der any of the above.

Provided further that, the **beneficial owner** for the purpose of (iii) above will be as under:

1. In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has a controlling ownership interest or who exercises control through other means.

Explanation-

- a. "Controlling ownership interest" means ownership of or entitlement to more than twenty-five per cent. of shares or capital or profits of the company;
- b. "Control" shall include the right to appoint majority of the directors or to control the management or policy decisions including by virtue of their shareholding or management rights or shareholders agreements or voting agreements;
- 2. In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alon e or together, or through one or more juridical person, has ownership of entitlement to more than fifteen percent of capital or profits of the partnership;
- 3. In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or b ody of individuals;
- 4. Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relev ant natural person who holds the position of senior managing official;
- 5. In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership.

An Agent is a person employed to do any act for another, or to represent another in dealings with thir d person.

For Works contracts, including Turnkey contracts, the successful bidder shall not be allowed to sub-contract works to any contractor from a country which shares a land border with India unless such contract or is registered with the Competent Authority.

A Certificate shall have to be given by all such bidders regarding their compliance with the provisions of GOI, MF, DoE, PPD OM no. 6/18/2019-PPD dated 23rd July 2020.

2. Requirements for Local Content in the product offered by the Bidder

- (a) The Bidders are required to note that for participating in this GeM Bidding, they shall be categorized in terms of the GOI, Ministry of Commerce and Industry, Department for Promotion of Industry and Internal Trade, OM No. P-45021/2/2017-PP (BE-II) Dated 16/09/2020, either as,
 - (i) Class-I Local Supplier offering products with minimum 50% of Local Content, or,
 - (ii) Class-II Local Supplier offering products with minimum 20% of Local Content or,
 - (iii) **Non-Local Supplier** offering products with less than 20% of Local Content.
- (b) Only the Class-I Local Suppliers, or, Class-II Local Suppliers as above shall be eligible t o bid for the present tender Item in Indian Rupee and this being not any global tender, Non-L ocal Suppliers are not eligible for bidding.

Provided further, where the item is so notified by the nodal ministry/department as having sufficient local capacity and local competition, only Class-I Local Supplier shall be eligible to bid.

- **(c) Local Content** in this regard shall mean the amount of Value added in India which shall, unless otherwise prescribed by the Nodal Ministry, be the total value of the item (excluding net domestic indirect taxes) minus the value of imported content in the item (including all customs duties) as a proportion of the total value, in percent.
- (d) It shall be mandatory for the participating Class-I, or, Class-II local suppliers as above to provide a self-certification declaring the percentage of local content (as per Govt. of India notification vide OM No. W-43/4/2-19-IPHW-MeitY dated 07/09/2020, No. P-45032/2/2017-PP (BE-II) dated 16/09/2020, as amended vide OM No. W-43/4/2019-IPHW-MeitY dated 12/10/2023 and further amendments, if any, as may be issued from time to time) in their offered product/ service item(s) in support of their claim for meeting the eligibility requirements for being Class-I or Class-II Local Supplier. False declarations, if any found, will make the bidder liable for debarment for up to two years as per extant rules along with other punitive actions as per Law.

3. Bid Security / Earnest Money Deposit

Bidders shall have to furnish Bid Security / Earnest Money Deposit @ 5% (Five per cent) of the e stimated price of the Item(s) offered as indicated against each below, separately for each offer in the for m of Fixed Deposit Receipt (FDR) or Bank Guarantee from any Nationalized / Commercial Bank in favour o f "PAO, MEITY, New Delhi" in the GeM Prescribed format. The Bid Security / EMD must remain valid for the entire period of requisite bid validity plus a period of forty-five days beyond the final bid validity period

4. Performance Security / Bank Guarantee upon Selection and Aw ard of Contract

Bidders will have to furnish, if selected and ordered against their offers, a Performance Security in the form of Fixed Deposit Receipt from a Commercial bank or Bank Guarantee from a Commercial bank in a format prescribed by us @ 5% (five per cent) of the accepted order value.

5. Purchase Preference

In doing so, Price Preference under Public Procurement (Make in India) Order 2017 (as revised vide GOI, Min. of Commerce & Industry, DPIIT Order No. P-45021/2/2017-PP (BE-II) Dated 16/09/2020) will be all owed as below.

- (a) Subject to the provisions of this Order and to any specific instructions issued by the Nodal Ministr y or in pursuance of this Order, purchase preference shall be given to 'Class-I local supplier in procuremen ts undertaken by procuring entities in the manner specified here under.
- (b) In the procurements of goods or works, which are covered by para 3(b) above and which are divis ible in nature, the 'Class-I local supplier' shall get purchase preference over 'Class-II local supplier' as well as 'Non-local supplier', as per following procedure:
 - i. Among all qualified bids, the lowest bid will be termed as L1. If L1 is 'Class-I local supplier', the c ontract for full quantity will be awarded to L1.
 - ii. If L1 bid is not a 'Class-I local supplier', 50% of the order quantity shall be awarded to L1. There after, the lowest bidder among the 'Class-I local supplier' will be invited to match the L1 price for the remaining 50% quantity subject to the Class-I local supplier's quoted price falling within the margin of purchase preference, and contract for that quantity shall be awarded to such 'Class-I local's upplier' subject to matching the L1 price. In case such lowest eligible 'Class-I local supplier' fails to match the L1 price or accepts less than the offered quantity, the next higher 'Class-I local supplier within the margin of purchase preference shall be invited to match the L1 price for remaining quantity and so on, and contract shall be awarded accordingly. In case some quantity is still left uncove red on Class-I local supplier, then such balance quantity may also be ordered on the L1 bidder.
- (c) In the procurements of goods or works, which are covered by para 3(b) ,above and which are not divisible in nature, and In procurement of services where the bid is evaluated on price alone, the 'Class-I lo cal supplier' shall get purchase preference over 'Class-II local supplier' as well as 'Non-local supplier', as per following procedure:
 - (i) Among all qualified bids, the lowest bid will be termed as L1. If L1 is 'Class-I local supplier', the contract will be awarded to L1.
 - (ii) If L1 is not 'Class-I local supplier', the lowest bidder among the 'Class-I local supplier', will be invited to match the L1 price subject to Class-I local supplier's quoted price falling within the margin of purchase preference, and the contract shall be awarded to such 'Class-I local supplier' subject to matching the L1 price.
 - iii. In case such lowest eligible 'Class-I local supplier' fails to match the L1 price, the 'Class-I local supplier' with the next higher bid within the margin of purchase preference shall be invited to match the L1 price and so on and contract shall be awarded accordingly. In case none of the 'Class-I loc

al supplier' within the margin of purchase preference matches the L1 price, the contract may be a warded to the L1 bidder.

(D) "Class-II local suppler will not get purchase preference in any procurement, undertaken by procuring e ntities.
